1 POLICY

1. Students are expected to abide by all policies regarding personal conduct, and refrain from actions that would be considered inappropriate, disruptive or disrespectful, or could cause potential injury, to persons or property, or interference with the rights and interests of other students, faculty, or staff.
2. Students are required to follow all protocols and procedures outlined in *CMCC's Return to Campus Playbook: Infection control and prevention in response to COVID-19* and Public Health Orders in place, now or in the future, to reduce the risk of spreading communicable disease. Failure to do so may result, without further notification, in disciplinary action, 3rd party action (i.e. enforcement agency) and/or issuance of a notice pursuant to the Trespass Act of Ontario.
3. Students are reminded that this Policy is applicable to all conduct on-campus as well as off-campus.
4. Students are individually responsible for their actions and/or misconduct whether acting alone or in a group and have an obligation to make responsible decisions concerning their conduct.
5. All suspected acts of misconduct will be investigated and may be subject to disciplinary action and penalty, which may include the imposition of a fine, restitution, alternative dispute resolution, suspension or expulsion from CMCC.
6. Acts of misconduct include, but are not limited to, the following:
 - inappropriate, disruptive, dangerous, aggressive or threatening behavior – including by electronic means
 - misuse of CMCC resources, equipment or supplies – including but not limited to computers and network, keys, records, permits and letterhead
 - mischief
 - vandalism
 - theft
 - infringing unreasonably on the work of others
 - violation of standards of conduct specific to classroom, laboratory, clinical or other learning environments
 - unauthorized use of equipment, material, patient records, or a facility or service
 - unethical behaviour
 - contravention of statute (e.g., Liquor License Act; Criminal Code)

- aiding or abetting in the commission of a non-academic offence
- workplace harassment and sexual violence

7. Any member of the CMCC community who has reason to believe that a violation has been committed by a student has a responsibility to report the matter promptly to the Director, Student Affairs or the Vice President, Academic.

2 PURPOSE

To establish professional standards of conduct expected from all students.

3 SCOPE

CMCC students, including individuals who were students at the time of the event(s), upon which a disciplinary proceeding is or may be based.
